



# COUNCIL LIFE MEMBERSHIP

## QUALIFICATIONS

A Home & School Council (H&S Council) wishing to honour a **member or individual for outstanding service** to the H&S Council may confer a Life Membership in the H&S Council.

This honour may be conferred on:

- H&S members who have given outstanding service to the H&S Council
- Individuals not actively engaged in H&S work who have made a special contribution to the H&S Council

A Life Member in a Home & School Council shall **not** have voting privileges.

## PROCEDURE

1. The H&S Council conferring the Life Membership shall provide the Federation with the full name of the recipient (as it should appear on the certificate), the name of the H&S Council and a brief summary of the member's or individual's service to the H&S Council.
2. The H&S Council shall submit a cheque for \$100.00 payable to the Ontario Federation of Home & School Associations.
3. The Federation will provide the H&S Council with a *Council Life Membership* certificate and a *Council Life Member* pin.
4. The Life Membership will be presented at a meeting or a special event of the H&S Council.
